This Bill provides the Appropriation for the 2014/2015 for the Financial Year ending 30th June 2015.

clause 1: states that when enacted, the Bill will be called the Appropriation Act 2014/2015 and will commence on the date of assent by the Head of State.

<u>Clause 2</u>: - provides for the grant and appropriation of \$492,542,095 from the Treasury Fund.

<u>Clause 3:</u> provides for the grant and appropriation of \$529,107 from the Public Trustee's Account.

<u>Clause 4:</u> - provides for the grant and appropriation of \$14,776,263 to the Unforeseen Expenditure.

A BILL INTITULED

AN ACT to authorise the appropriation of certain sums of money out of the Treasury Fund and the Public Trustee's Account and their specific application to outputs and sub-outputs delivered by Ministries/Departments, outputs delivered by Third Parties and Transactions undertaken on behalf of the state for the Financial year ending on the 30th June 2015.

BE IT ENACTED by the Legislative Assembly of Samoa in Parliament assembled as follows:-

- **1. Short title and commencement-**(1) This Act may be cited as the Appropriation Act 2014/2015.
- (2) This Act commences on the date of assent by the Head of State.
- 2. Grant and Appropriation of \$492,542,095 out of the Treasury Fund-(1) There may be issued out of the Treasury Fund and applied to the outputs or sub-outputs delivered by individual Ministries/departments or outputs to be delivered by third parties, or for transactions on behalf of the state for the Financial Year 2014/2015 sums of money which do not exceed in the aggregate the sum of \$492,542,095.
- (2) The sums authorised to be expended under subsection (1) are separately appropriated for the outputs and sub-outputs to be delivered by Ministries/departments, outputs to be delivered by third parties or transactions on behalf of the state, as specified in the Schedule.
- **3. Grant and Appropriation of \$529,107 out of the Public Trustee's Account-**(1) There may be issued out of the Public Trustee's Account (held in the ANZ Bank, Samoa Ltd.) and applied to the outputs and sub-outputs, salaries and other outgoings, charges and expenses lawfully incurred or payable in administering the Public Trust Office for the Financial Year 2014/2015 sums of money which do not exceed in the aggregate the sum of **\$529,107**.
- (2) The sums authorised to be expended under subsection (1) are appropriated to the use of the Public Trust Office.
- **4.** Grant and Appropriation of \$14,776,263 out of the Treasury Fund-(1) There may be issued out of the Treasury Fund and applied to Unforeseen Expenditures for the Financial Year 2014/2015 sums of money which do not exceed in the aggregate the sum of \$14,776,263.
- (2) The sums authorised to be expended under subsection (1) are appropriated for Unforeseen Expenditure.
