ROAD TRAFFIC AMENDMENT ORDER 2009

Pursuant to section 73 of the Road Traffic Ordinance 1960, the **LAND TRANSPORT AUTHORITY** with the consent of the Minister of Works, Transport and Infrastructure makes the following orders:

Arrangement of Provisions

1. Title and commencement
2. Speed Limit
3. Standstill

1. Title and commencement-(1) This Order may be cited as the Road Traffic Amendment Order 2009.

(2) This Order shall come into force on Monday 24 August 2009.

2. Speed Limit - In the Road Traffic Order 1994 Clause 3 is amended as follows:

(a) for subclause (3), substitute:

“(3) That the speed along the Le-Mafa pass road commencing from Falevao village to the turn off at Lotofaga to Sapoe be limited to 20 miles per hour.”;

(b) for subclause (5), substitute:

“(5) That the speed along the access road from the main road turn off at Salelologa to the Wharf at Savaii be limited to 20 miles per hour.”; and

(c) for subclause (7), substitute:

“(7) That the speed of any truck carrying any load of more than three (3) tons be limited to 25 miles per hour on any road where speed limits are not in force.”.

3. Standstill-(1) Every driver of any motor vehicle on 7th September 2009 between 10 minutes to and 10 minutes past 6am, shall stand and stop the vehicle at any place or area in Samoa, 10 minutes before 6am to change from the right to the left side of the road, and then stand and stop the vehicle for another 10 minutes, before driving on the left side of the road.

(2) This standstill shall not apply to a driver of a vehicle for fire brigade, ambulance or police purposes if the observance of such would hinder the use of the vehicle for the purpose for which it is being used on that occasion.

(3) This standstill shall not apply also to a driver of a vehicle authorised by the Chief Executive Officer of the Land Transport Authority to be used for any traffic management purpose during the standstill.
