Explanatory Memorandum

1.0 Object and reasons:

This Bill contains the First Supplementary Appropriation for the Financial Year 2017/2018.

Clauses:

- Clause 1:** - provides the short title and commencement date.
- Clause 2:** - provides for the grant and appropriation of **\$11,966,943** out of the Treasury Fund to be applied to the outputs and sub-outputs of Ministries and Departments as set out in the First Schedule.
- Clause 3:** - provides for the reduction of amounts earlier appropriated for particular Ministries and Departments in the Second Schedule and re-appropriates such funds in the manner set out in the First Schedule.
- Schedules:** - provides for the First Schedule setting out funds authorised to be expended under section 2 and funds reallocated under section 3, in respect of Ministries and Departments specified; and

- provides for the Second Schedule setting out the amounts to be reduced from the Ministries and Departments listed.
