REPORT FOR THE LEGISLATIVE ASSEMBLY

“ROAD TRAFFIC AMENDMENT BILL 2015”

**WORKS, TRANSPORT & ENVIRONMENT

SEQUENCE OF COMMITTEE CONSIDERATION:

(Referred on 20/03/2015)
Road Traffic Amendment Bill 2015.

The Works, Transport & Environment Committee² was scrutinizing the Road Traffic Amendment Bill 2015, as referred to by the Legislative Assembly on the 20th March 2015.

PROCEEDINGS:

The Committee invites submissions from the public by broadcasting a notice on Television (S.Q.B. TV 1) and on radio (2AP) about the Amendment Bill.

The Committee also requested the assistance of the following as they considered this Bill.

FINDINGS:

The Road Traffic Amendment Bill 2015 seeks to amend the Road Traffic Ordinance 1960 (Principal Act).

The main objectives of the Amendment Bill is to repeal some provisions in the Principal Act, to make it compulsory for all drivers to carry their license at all times when driving and failure to produce their license on request by an authorized officer is an offence.

The Bill also amends the maximum net weight for vehicles by substituting “60cwt” (Centum Weight) to “3 tonnes”. The Committee asks for a valid explanation of this amendment, so as to align with the current Metric Act 2014.

Other amendments proposed in this Bill prohibit a person less than 25 years of age from driving a motor omnibus. The committee noted that this amendment should have been research with close observation of New Zealand and Australia, according to omnibus drivers, together with appropriate explanations that has caused this limitation of drivers’ ages.

It is now inserted in this bill the powers of authorized officers to stop, impound and sell impounded vehicles. It is a provision that has strongly supported by the Committee noticing the difficulties faced by Officers on this matter.

BILL CONSIDERATION:

After the consideration of this Bill it has satisfy the Committee and all provisions and amendments given are appropriate.

RESOLUTION:

After the consideration in Detail of the Bill the Committee resolves to recommend to the Assembly:-

That the Road Traffic Amendment Bill 2015, progresses without any amendments.
